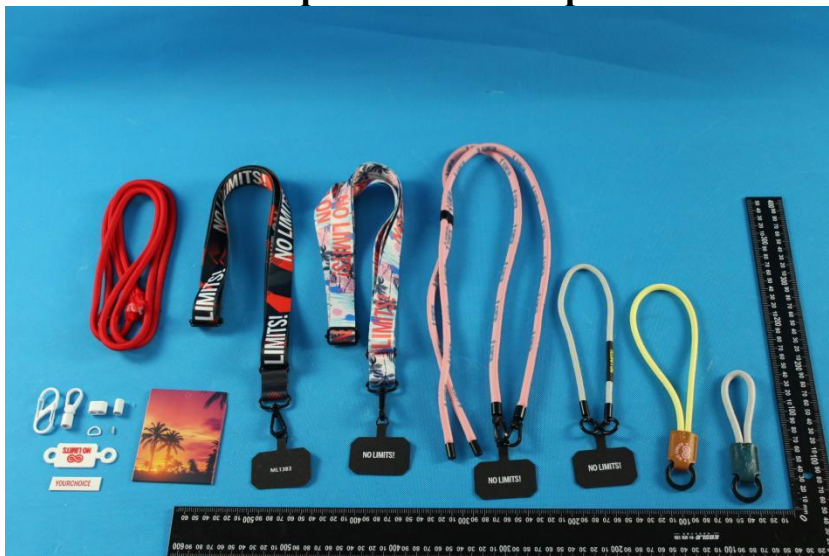

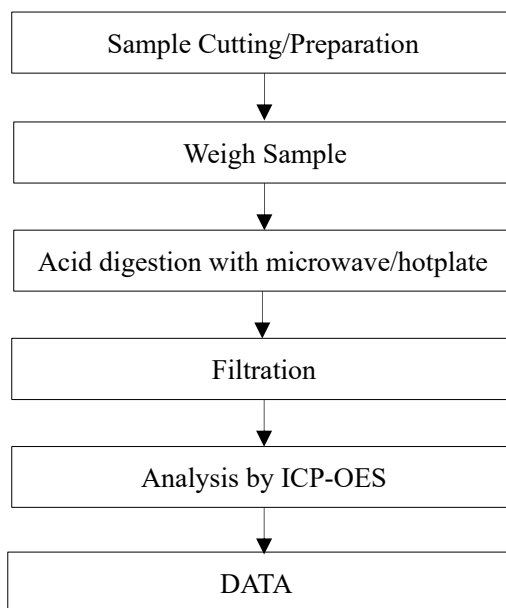

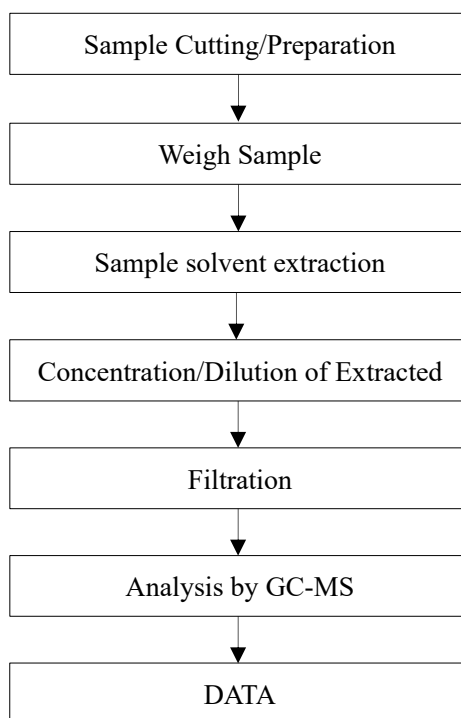

Test Flow Chart of Phthalates



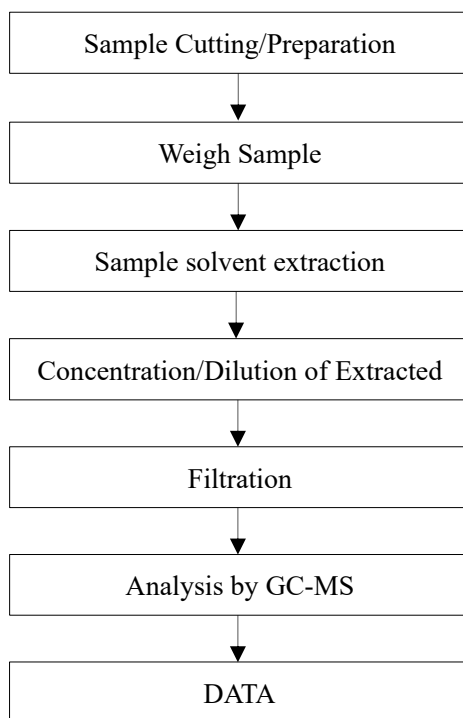

Test Flow Chart of Polycyclic-aromatic Hydrocarbons (PAHs)



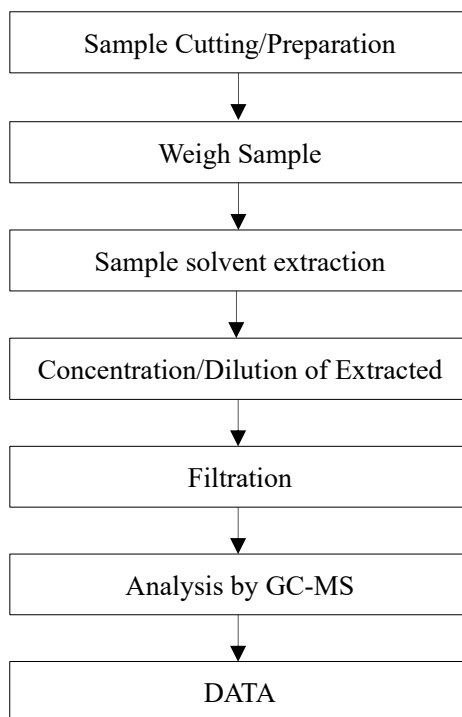

Test Flow Chart of AZO



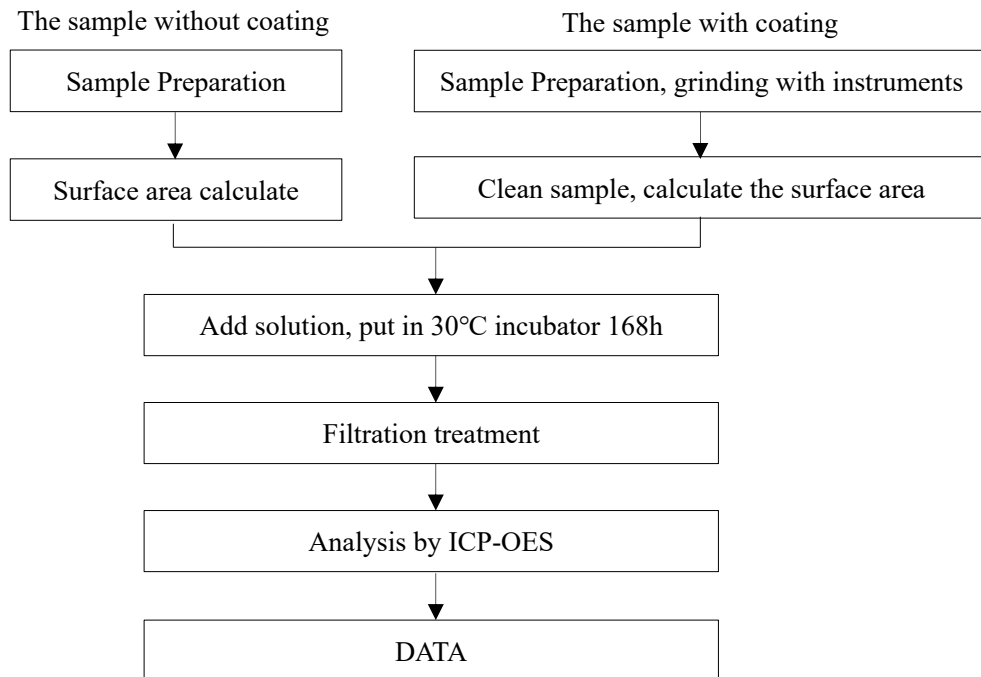
