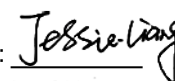

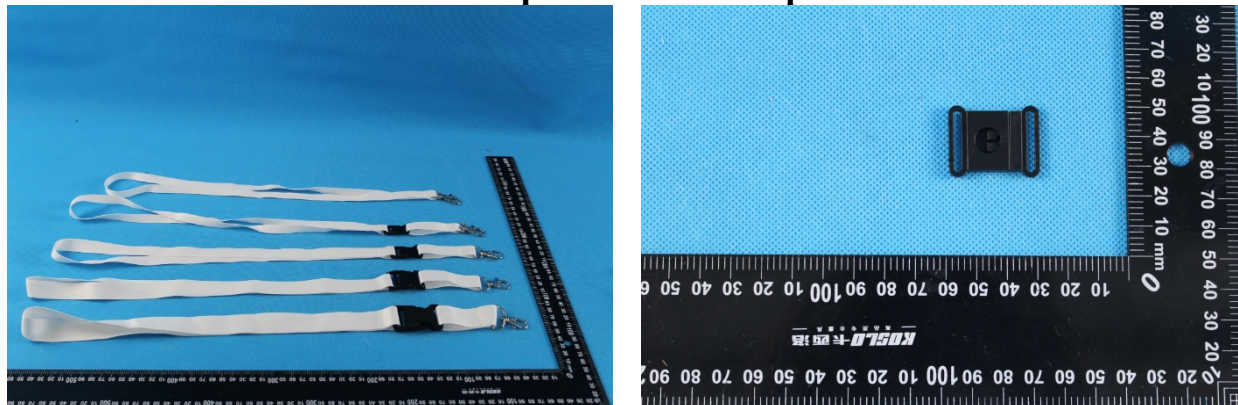

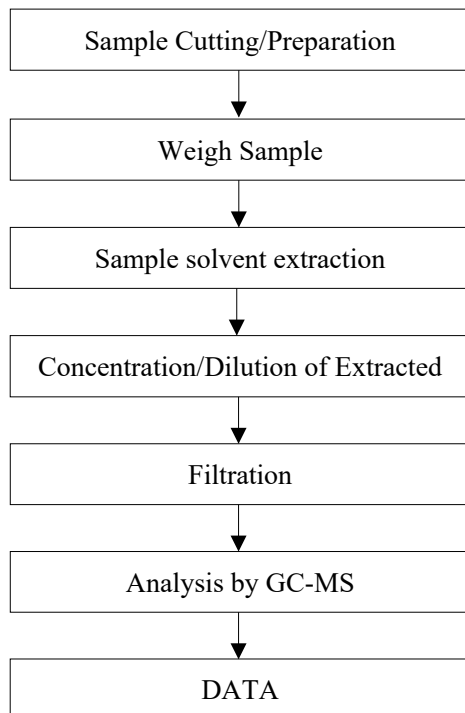

Test Flow Chart of Phthalates



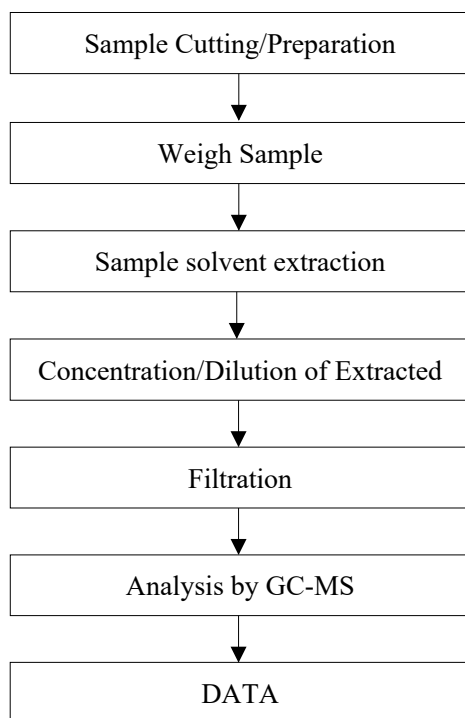

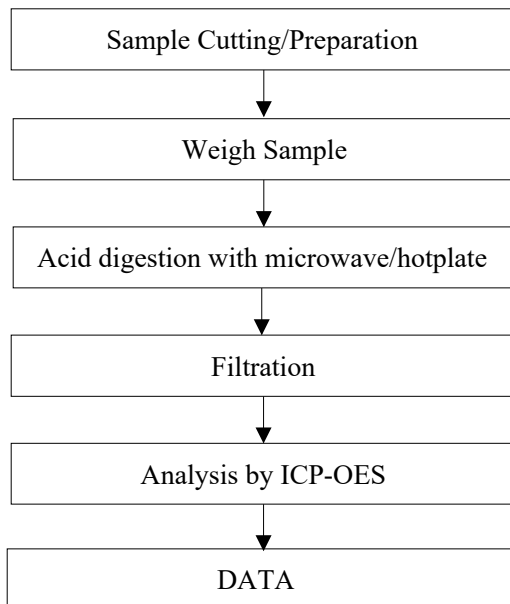

Test Flow Chart of Heavy Metal Content



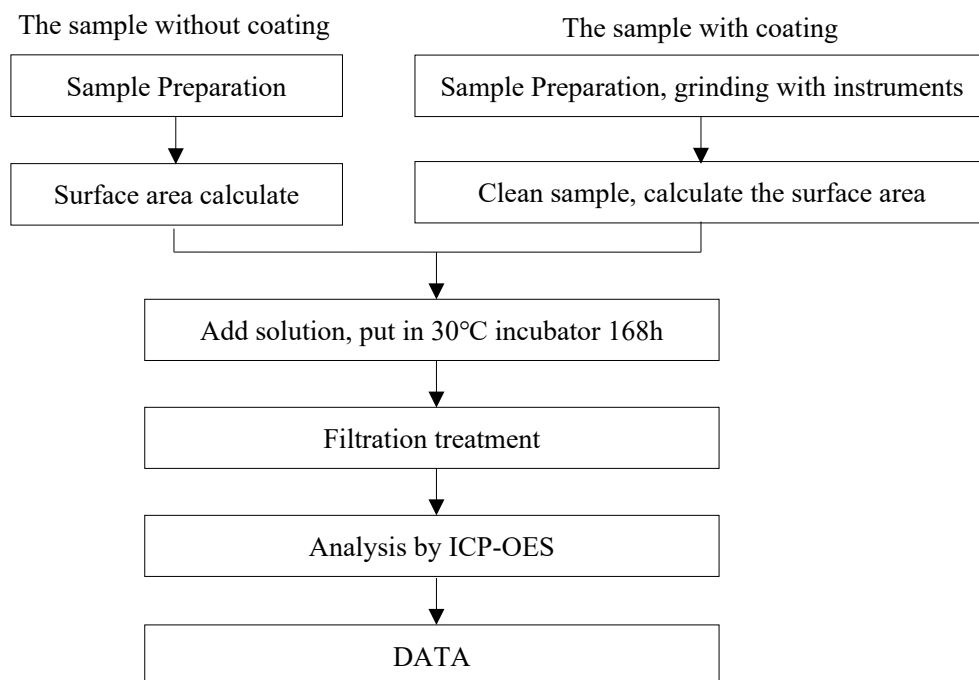
