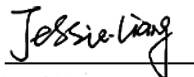

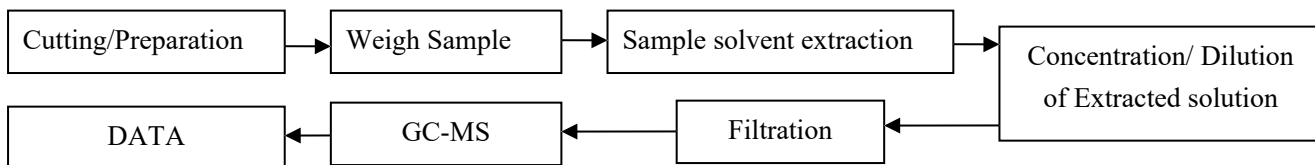

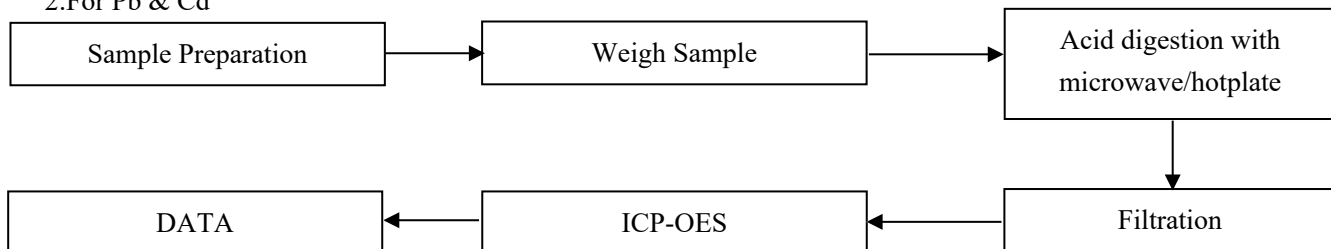

Test Flow Chart

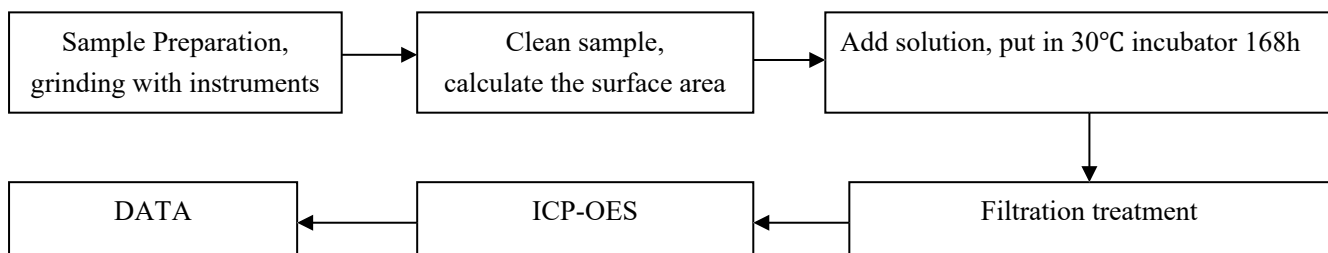
1. For Phthalates

3. For Nickel Release



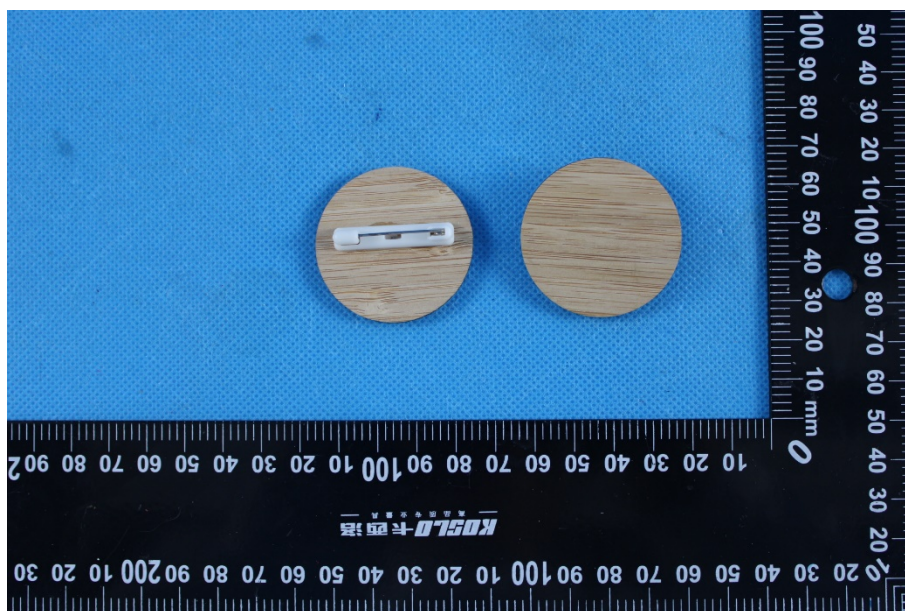
